Inspection and Testing of Independent Smoke Alarms

There is a wide range of fire protection equipment used in a single building to maintain fire safety standards.

Fire protection systems and equipment are required to be in a functional state that allows them to operate at all times.

Undertaking regular maintenance in line with an industry-wide standard is one way of improving the reliability of fire protection systems and equipment that benefits all stakeholders.

After completing this training, the student will have the required skills, knowledge and procedures to inspect test and maintain independent smoke alarms in accordance with AS1851.

Currently, in Australia, each State and Territory has a unique regulatory system that governs the minimum requirements for maintenance of fire protection systems and equipment.

Some jurisdictions have non-specific provisions that simply require the owner of a building to ensure that such systems and equipment continue to perform to a standard no less than that to which they were initially designed and installed. Other jurisdictions have precise regulatory requirements that can vary from building to building.

Students are advised to check their State or jurisdiction regulatory licencing requirements before registering.

A licensed electrical contractor is required to maintain, disconnect or install mains powered smoke alarms.
