

### **Course Delivery & Duration**

Our program is designed to be delivered predominantly in the workplace, through a combination of workplace activities, online learning and small group sessions. The program can be undertaken as an apprenticeship to eligible participants.

We acknowledge that the target group for this course is people who are currently employed and we take pride in being able to deliver a flexible, tailored program that works around you whilst retaining without compromising the integrity of the qualification.

The expected duration of the program is 2 years full time or 3 years part time, however this will depend on the prior experience and existing skills and knowledge of the student. In instances where the course is delivered as an Apprenticeship, it would be delivered over a period of approximately 3 years.

#### **Entry Requirements**

There are no formal entry requirements, however as the program is delivered in the workplace you must be employed in a related role within the fire protection industry and have access to the necessary resources and equipment to enable training and assessment to be undertaken. On enquiry for the course, we will provide you with a comprehensive checklist of what is required.

# In addition you will be required to:

- ✓ Have completed year 10 or equivalent
- ✓ Be able to read and write in English to the level required of the job (evidenced by holding a trade qualification or IELTS 6.0 or equivalent)
- ✓ Have a reasonable level of physical fitness to handle the physical demands of the job including manual handling of equipment, accessing small spaces and climbing ladders
- ✓ Have digital literacy skills and IT equipment required to be able to effectively engage in online learning.

This course requires evidence of previous experience or study in the fire protection field or trade-related field.

Prior to enrolment we will conduct a pre-screening interview and LLN assessment to determine whether the course is right for you. Axiom Compliance Learning is committed to meeting the learning needs of each of its learners and will support all enrolled students throughout their learning journey to provide the best opportunities for success.

#### **Licensing & Regulatory Information**

This qualification includes units of competency common to other qualifications in the plumbing industry as well as specialist fire protection units and can provide a pathway to further learning and work in the fire protection industry.
