#### **PROGRAM OUTLINE**

Blended learning (also known as hybrid learning) is a method of teaching that integrates technology online learning with traditional instructor-led face-to-face classroom activities with on-the-job tasks.

FACE-TO-FACE TRAINING, The course is a five day block. To ensure the quality of training, the number of participants in each course is limited to 10. This training is facilitated at 47 South Tce, Adelaide MBA. 8am to 4pm

OR

VIRTUAL CLASS ROOM (online with a live trainer). Four day block and additional single day. A virtual classroom is a digital platform designed for learning that employs a delivery format such as Zoom. Here, a live trainer facilitates online training sessions, focusing on critical course content and guiding students on how to navigate through the program. This medium enables real-time engagement through audio and video communication allowing trainers to interact with their students as they participate in learning and assessment activities. 9am to 3pm

#### **ONLINE LEARNING**

In addition to the face to face session, this program has a self-paced online learning portion, where students research, prepare and submit their assessments via the Learning Management System (LMS). Students will undertake personal study and develop fire system assessments using templates and available resources based on genuine work performances for evaluation purposes. Students' tasks require them to develop various documents, and service reports, with outcomes commonly found in the industry.

Students will complete knowledge tests at different intervals corresponding to the covered subjects. To research the answers, students can refer to the course training materials, notes, and other relevant references. The training is structured in a logical sequence to enable a step-by-step learning process. The activities are presented in a clear manner. They are directly linked to the course and industry information, allowing assessors to ascertain that students can competently apply their knowledge and skills.

The duration of the course is flexible, with students having up to 6 months to complete the online learning and tasks. The more time students dedicate to the online learning component, the faster they can work through the content and assessment tasks.

Some of the required work performance evidence to complete this course is as follows:

Twenty fire hose reels across a minimum of five different sites including at least five fire hose reels installed in a recess, cupboard or cabinet

Ten extinguishers including at least one of each of the following water, dry chemical, carbon dioxide, wet chemical and foam.

Twenty fire and smoke doors over two different sites

Thirty single point emergency light fittings or exit signs over five different sites Please note some of the work performance tasks are covered in the face to face training.
