Zoom Training

- Students are required to attend scheduled zoom training for **6** hours.

 - The student will have access to their trainer via zoom conferencing systems, either by phone or computer.
- The level of participation is entirely up to the student.

Face to Face Training-1 day

- Students are required to attend scheduled face to face training at the nominated venue.
- Students will receive correspondence via email and a text message containing **face-to-face** course and venue information, a few days before.

Student coordinators are available to discuss the login, resources, and other ways Axiom Compliance can support the student.

Program Outline and Assessments

- At least 2 Fire Extinguishers
- At least 1 Fire Blanket
- Pictorial Evidence of inspected equipment
- Complete a Defect and Action Report
- Complete a System Condition Report
- Complete an Annual Fire Survey

Knowledge Assessments: Students will undertake written and online knowledge assessments. Students may research the answers from the course training materials and notes as well as relevant references.

Computer Skills: Students need to be familiar with electronics/computers and have the ability to use our online learning portal to access, download and upload course material for the online component of the course and complete online knowledge assessments.
